GUIDELINES

- Nurse Practitioner and Registered Nurse can register as long as they are licensed to inject in their own country
- ***Early bird fees are valid until Nov 6th, 2024.** After early bird, regular price apply
- Cancellation of a pass must be made in writing:
 - > Cancellation requests received before **Nov 6th, 2024:** 70% of the pass fees will be refunded
 - > Cancellation requests received after **Nov 6th, 2024:** there will be no refund
- Force Majeure:
 - For the purposes of this clause, "Force Majeure" events shall include, but not limited to, general and labor strikes, invasions, hostilities, war, rioting or similar situations, acts of government or state* such as lockdown and quarantine measures, immigration and transport restrictions, and acts of nature such as fires, floods, extreme weather or other emergency.
 - > THINKIN shall assume no liability whatsoever in the event the activity is cancelled, rescheduled or postponed OR changed into another format as a result of a "Force Majeure" event beyond its reasonable control.
 - > THINKIN shall assume no further obligation to refund any expenses, such as travel or accommodation, incurred by the client in case the activity is cancelled, rescheduled or postponed as a result of a "Force Majeure" event.
 - > If THINKIN determines that the activity needs to be cancelled as a result of a "Force Majeure" event, THINKIN shall refund 100% of the invoice amount.
 - > If THINKIN determines that the event needs to be rescheduled as a result of a "Force Majeure" event, booking remains binding and purchasers will be entitled to participate to the rescheduled event without any further refund right.
